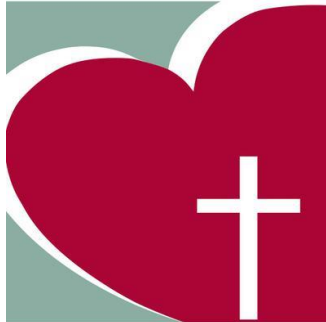

Our program incorporates the many health and social services provided by CCANO and its partner organizations to help these patients achieve a better quality of life. Navigating the medical and social service landscape can be an intimidating process, especially for those with high-needs and chronic conditions. Our Patient Navigators work with these individuals and their families to map out an intensive care plan that leads to improved self-sufficiency in accessing care. Through Health Guardians, CCANO offers an integrated system of intensive medical and behavioral care management and wraparound social services for this high-need patient population. Health Guardians staff members also provide intense case management and counseling for those residing in Sacred Heart Apartments (supportive housing for homeless veterans in New Orleans)

includes two housing components for families that provides 3-6 months of rental assistance to homeless families with children (may be extended by special circumstances). Families must be living in an emergency shelter for at least 7 consecutive days, living on the streets or in a place not meant for human habitation (will be verified by outreach team). Services include: home-based case management, life skills training, budget planning, advocacy, linkages to mainstream resources and referrals for additional services.

Immigration Services ...
(Est. 1961)

provides free or low-cost legal immigration counseling and representation to families and individuals who are eligible for immigration benefits but cannot afford private attorneys. Services include assistance in obtaining family-based immigrant visas, adjustment of status to legal permanent residency, naturalization (citizenship) applications and preparation classes, VAWA petitions, U-visa applications, asylum (for children only), Special Immigrant Juvenile Status, Temporary Protected Status (TPS), Deferred Action applications (DACA), fiancée petitions, consular processing, travel documents/advance parole, renewals, work permit renewals, affidavits of support, etc. We have specialized pro bono programs to provide legal representation and holistic case management support for survivors of domestic violence/abuse, unaccompanied children, survivors of trafficking and other crimes and those detained in immigration facilities.
