## **AHCA Chair Continues a Legacy of Compassion**

s Catholic Charities celebrates its centennial year, the theme of *legacy* resonates deeply in the stories we've shared. Trey Reymond, who is serving as the 2024 chair for the Archbishop Hannan Community Appeal (AHCA), is yet

another example of an individual, fueled by the legacy of his family, helping lead Catholic Charities' vital campaign into the next Century of Service.

The annual AHCA, which is powered by the dedication of volunteers, supports Catholic Charities and addresses pressing community challenges. This year's goal is \$1.75 million to support the nearly two dozen programs Catholic Charities operates to serve those most in need.

Serving as this year's campaign chair is a natural fit for Trey, a local attorney. His father, Leon J. Reymond, served as AHCA chair in 2001, and has been an invaluable resource as Trey works to help the agency live up to the legacy of Archbishop Philip Hannan, a stalwart champion of those facing crisis in the Archdiocese.

"My father's life-long work for the

good of society is an inspiration to me. He made his difference through Catholic nonprofits, including Catholic Charities. He is still very interested in the organization and is always eager to offer advice," Trey said.

Some of Trey's first memories as a young professional include participating in bus tours that visited the various ministries of Catholic Charities. He has been involved with the boards of several organizations, including the Catholic Community Foundation and the Daughters of Charity (now Ascension DePaul

Services). As a board member with LCMC Health, he was instrumental in securing a \$15,000 gift for Catholic Charities to use this year for Thanksgiving baskets for families in need.

Faith and family play a significant role in how Trey conducts his life. It's these same qualities and character that Trey hopes to instill in his own children.

> "My faith dovetails with my work for Catholic Charities and its mission in that doing for others is a central teaching of Christ and what the Catholic faith is about. It's important to give back and make sure everyone has an opportunity in life for a hand up when they need it," Trey said.


Trey is also particularly honored to have the opportunity to serve as chair during the centennial celebration of Catholic Charities.

moment can create a ripple effect that can set you down an unexpected path. For Danena Williams, one bad decision in her twenties would see her face seemingly impossible challenges over the course of nearly two decades.

As an accounting major at Grambling State University, Danena was charged with two counts of armed robbery and sentenced to 20 years in prison. It was her first run in with the law. For any ordinary person, they might call it a day. Danena deeply regrets her actions. Her remorse fueled her drive to break the mold, finding ways to pursue opportunities and regain control of her life.

"I stayed focused on making the best of the time. Twenty years is a long time, and I didn't want it to be wasted time. I took every class, every program, every certification, and finished my accounting degree. Everything they had I did," Danena said.

initial set of parole fees. It was the opportunity of a lifetime," Danena said.

But this opportunity almost didn't happen.

During her incarceration in 2015, Danena was diagnosed with non-Hodgkin lymphoma and given two months to live. This diagnosis put her faith to the test. Throughout her life, even while in prison, Danena has always tried to find the positive in the midst of the negative.

"I'm a fighter and a firm believer in God and the amazing things He has done. I prayed and stayed connected to Him," Danena said.

Danena received another opportunity to help others in similar situations when she was asked to visit the state penitentiary for women (LCIW) and speak with prisoners during job fairs. She realized, as hiring manager at IHOP, she was in a place to hire incarcerated people when they are released. So far, she has hired seven people.

"People who are incarcerated and those who are formerly incarcerated need to see that you can come home and have a good life. You can beat the odds. Just because a person makes a mistake doesn't make them a bad person. Just because someone has been incarcerated doesn't mean change can't happen," Danena said.
